- The final schedule/revisions will be posted at Kingswood Music Theatre on the morning of the competition. If your team is unable to compete, please call Canada's Wonderland and PCA prior to NOON on Friday May 8th.
- There will be a double panel of judges used such that two divisions can run alternately.
- There will be a designated practice area. When you arrive at the theatre, sign up to receive your practice time. Also, please note that unauthorized behind the scenes areas at Kingswood Music Theatre (including the lawn seating) are not permitted to be used as a practice area for safety reasons.
- Please register on time to help us establish clear start times for all the teams. **The competition will start at 11 am.** Division and team performance times will be posted by Thursday May 7th on-line at: **www.PowerCheerleading.com** — click on COMPETITIONS.
- Teams are asked to sign in at the Park between 9am – 10 am if you are performing in the morning. **IMPORTANT:** Those teams competing in the afternoon can arrive after 10 am.
- At registration, teams will receive their starting positions, with the **competition beginning at 11 am.** Each team will perform its routine once. Please clear up any questions you might have before the Competition.
